YCC-2020 Eligibility Standards

February 28, 2020

The YCCI Board of Director reserve the right to consider, approve, or decline all applications, and maintains the right and authority to dismiss any participant from YCC-2020, and other programs based on the best interest of the organization, the safety & welfare of all participants, families, stakeholders, and collaborative partners associated with YCCI regardless of the applicant's eligibility status.

YCC-2020 has two group levels of participation; Level One is for Youth ages 14-17, and Level Two is for Young Adults ages 18 - 21. In addition to core training & activities of the overall program, Level Two participants receive additional leadership, mentoring, work readiness training, and job search assistance.

To be eligible for YCC -2020, Youth and Young Adults must be between ages 14 and 21. There are two levels of participation.

Level One: Age 14 to 17. Participants must be age 14 by to 17), and Level Two (Age 18 to 21). Level One Participants must be age 14 by June 1, 2020, if Level One participants turn 18 the program, they may be eligible for transition to Level Two. age 17 and not turn 18 during the program. submit applications packets and schedule an **Intake Interview <u>before</u> May 16th.** Parents/Legal Guardians of Level One participants (age 14-17) are required to attend the Intake Interview with those participants. To remain in the program, all participants must attend planning sessions, preparation meetings, and participate in fund-raising efforts.

YCC - 2020 is open to youth and young adults age 14 to 21. Applicants are asked to adhere to our application process. Attempts to bypass this process may affect the outcome of the request. YCCI is committed to replying to all application requests within 48 hours from the date of submission. To participate in YCC-2019 applicants must meet the following criteria:

- Participants must turn the age 14 by June 4th, and have parent/guardian representation
- Participants age 18-21 undergo a mandatory criminal background check
- Participants with criminal convictions must obtain approval from the appropriate State agencies and

Department of Juvenile Justice.

• Participants with behavioral diagnoses must obtain written recommendation/ approval from their treatment specialist.

Although YCCI Statesboro is willing to accept participants from other regional and National locations based on space availability, we primarily focus on the Southeast region of Georgia. Applicants from low income families and rural areas commonly receive priority in program placement.

Program Cost:

The expenses for YCC-2020 include 2 weeks of lodging, meals, transportation, training materials, access to fabrication laboratory, and field trips. Financial sponsorships are available on a limited bases, and **may reduce the cost of attendance by over 90%**. Program cost is estimated at \$1,695 per person. With sponsorships, eligible participants pay \$50 nonrefundable registration and \$100 tuition. Eligible participants may be able to attend free of charge.
